Leadership Report (presented by Rachel and Jennifer):

- Last week, on Thursday night, the school hosted Meet the Teacher. There were almost 300 people in attendance!

Treasurer's Report:

- Currently, Mamta does not have any of the financial information. However, Jamie has the amount as she has said paperwork delivered to the office. The total combined amount is \$20,362.85, with Account #1 at 4,750.53 and Account #2 at \$15, 362.85, respectively.

Old Business:

Gaga Ball Pit Updates and Information:

- Asphalt must be installed for approval, estimated at \$5000, with another 3 or 4 grand for the actual construction.
- Ms. Elliot thought it would be good to have parents and students voice their input as well, through a survey for staff and students. Here they would vocalize their desires, almost like a wish list.
- Another possible hurdle with the construction of the gaga ball pit, would be dealing with water drainage. There are hills surrounding the area, so location is integral. The other issue is the number of children actually playing in the pit, considering how many children are attending in the school. The third issue would be safety concerns, as have been injuries in the pit.
- There was a discussion on whether or not a playground could be installed. Unfortunately, there isn't much real estate around the circumference of the school that is just for the school. There is much that is owned by the city, and used on evenings and weekends. A playground is not feasible for the area around the school, as well as the topography. The biggest hurdle would be the cost of a playground, and this would run in the hundreds of thousands.
- This discussion will be tabled for future discussion, to see what is wanted by the students, as well as what is feasible. This will be discussed between the principal and vice, as well as staff.

New Business:

- We got very close to being on the list for AGLC, but staff cannot confirm. AGLC needs to speak with parents rather than the school. It will be necessary for Dhaivat to contact the AGLC and confirm whether or not we are on the list for Casino. Dave will send Dhaivat the contact information, and forward the thread of emails sent between PC and Casino.
- Parents were encouraged to add their contact information in the chat in order to join the WhatsApp chat for another avenue of communication.
